REQUESTING <u>6-MONTH</u> PERMIT FOR: DIGGING PERC HOLES, PLANNING & DESIGN OF SEPTIC SYSTEM, AND MINIMAL DEBRUSHING OF NATURAL GROWTH TO FIND LOT LINES.

## **PERMIT REQUIREMENTS FOR LOT ACTIVITY:** (Please read carefully)

- DURING PERC HOLE DIG, OTHER GROUND ON THE LOT MUST NOT BE SUBSTANTIALLY DISTRUPTED, EXCAVATED, GRADED, OR STRIPPED.
- BACKHOES, MINI EXCAVATORS, AND SIMILAR EQUIPMENT MAY BE USED TO DIG PERC HOLES.
- EQUIPMENT AND VEHICLES SUCH AS BACKHOES, MINI EXCAVATORS, FRONT LOADERS, AND BULLDOZERS ARE **NOT** TO BE USED TO DEBRUSH, FIND LOT LINES, OR CLEAR/REMOVE THE NATURAL VEGETATION.
- ONLY HAND OPERATED MANUAL AND MOTORIZED TOOLS SUCH AS BRUSH CUTTERS, CHAINSAWS, AND WALK-BEHIND BRUSH MOWERS ARE PERMISSIBLE TO REDUCE NATURAL VEGETATION FOR THE PURPOSE OF SEPTIC DESIGN. (SEE ATTACHED EXAMPLES)
- PER RIVIERA COVENANTS, SECTION 7.15, **NO TREES MAY BE CUT OR REMOVED** UNLESS THEY ARE LESS THAN 6" (six inches) IN DIAMETER MEASURED AT 1' (one foot) ABOVE THE GROUND\*. TREE REMOVAL OF ANY TREES OVER 6" (six inches) IN DIAMETER MEASURED AT 1' (one foot) ABOVE THE GROUND MUST BE APPROVED AND PERMITTED BY ACC-FORESTRY COMMITTEE.
  - \*ANY TREES CUT DOWN THAT ARE LARGER THAN 6" (six inches) IN DIAMETER MEASURED AT 1' (one foot) FROM THE GROUND WITHOUT PERMITTING ARE SUBJECT TO A \$2,500 FINE PER TREE ISSUED BY THE BOARD OF TRUSTEES.
- SEPTIC DESIGN & ADDRESS SIGNAGE REQUIRED BY PIERCE COUNTY IS PERMITTED ON THE LOT BUT MUST BE REMOVED PRIOR TO RIVIERA FINAL INSPECTION.
- PRIOR TO REQUEST FOR FINAL INSPECTION AND REFUND OF DEPOSIT FEES, ALL PERC HOLES MUST BE FILLED IN
  OR A SITE DEVELOPMENT PLAN MUST BE SUBMITTED TO THE ACC COMMITTEE.



ALL WORK MUST BE COMPLETED PRIOR TO PERMIT EXPIRATION. MEMBERS MAY MAKE A WRITTEN REQUEST
FOR A ONE-TIME 6-MONTH EXTENSION IF NEEDED.
 I HAVE READ AND AGREE TO COMPLY WITH <u>ALL REQUIREMENTS OF THIS PERMIT</u>, AND I/WE TAKE FULL
RESPONSIBILITY FOR ANY CONTRACTOR WE HIRE FOR THIS PROJECT, AND THE CONTRACTOR, IF APPLICABLE, IS
AWARE OF THE CONTENTS OF THIS PERMIT AS NOTED BY HIS/HER SIGNATURE BELOW.

Upon submission of this completed form and successful payment of the refundable permit fee to the Riviera Community Club Office, the Perc Hole Permit is granted through standing approval by the Board of Trustees and their Designees, the Architectural Control Committee, for a length of 6 months.
