Nope....just Jeremy from Grounds!

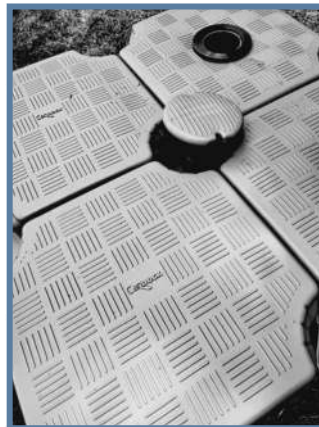
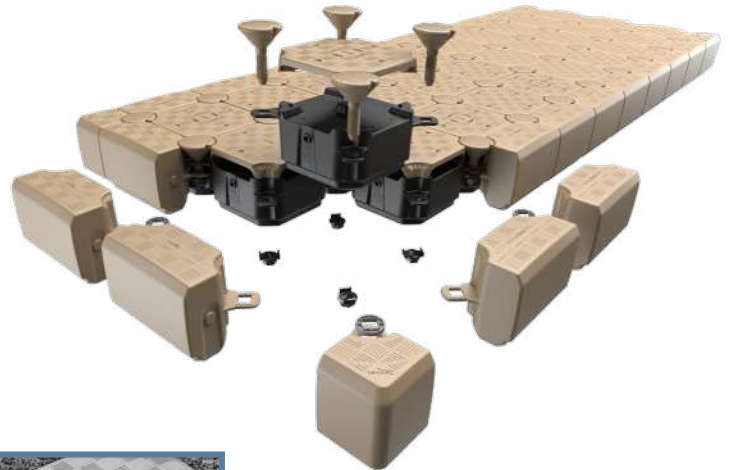


NEW DOCK installed at the Narrows Finger Park

The wooden dock has been replaced with a Candock System floating dock – made of interlocking blocks. Eventually all ‘Riviera’ lake docks will be upgraded to this system.

The Candock system is made of high density polyethylene resin (not recycled plastic). This makes it very resistant to impact, climate change, water, sun, and many chemical products.

With the Candock system, the concept of “maintenance-free” means ZERO maintenance – no more, no less. No more lost time, no more expense, and no more work to be done on a conventional wooden or metal dock year after year and comes with a 20 year warranty!

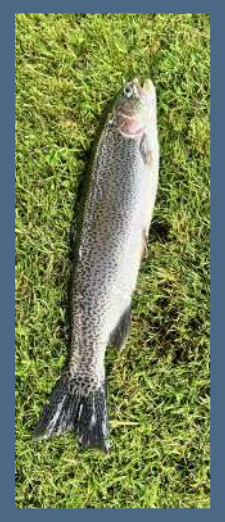
They are intended for day use only—if you pack it in – please pack it out.

The RCC would like to shine a little light on these incredibly dedicated volunteers on our island. V.I.P. works with the PC Sheriff and is always abreast of the best way to serve our islanders. They do free house checks for homes that will be unoccupied for long periods. They are active in the community when things happen like ferry service being suspended or a power outage for long periods and during our community events.

They can help you with reporting to the sheriff's office. They are known as the
"Eyes and ears of the Pierce County Sheriff."

The VIP is ready to answer any questions you have and help you get added to their 'list.'

V.I.P. is a non-profit organization. They receive some funding from Pierce County and are trained for the role as a V.I.P. member. They are always looking for volunteers - if you think you'd like to become a member of the team, please reach out to them at the phone number above.

SAFETY

A Deputy Sheriff attended our May Board of Trustees meeting to talk about safety, protecting our neighbors and property here in our community especially during our busy summer season.

Below is the advice given by the Deputy:

If you see something, say something!



-If something occurs like theft or vandalism, file a report with the Sheriff's Dept, don't just call 9-1-1.

-Let neighbors you trust know when you will be gone and vice-versa.

-Install lights, especially motion sensing lights, and cameras.

-Lock up your valuables and keep things out of sight.

-Start a neighborhood watch on your cul-de-sac or street. Exchange contact info to keep each other informed.

TANSY RAGWORT— NOXIOUS WEED CONTROL

Tansy ragwort is toxic and a threat to livestock and agriculture. All plant parts are toxic, with the highest amount of alkaloids in flowers, then the leaves, roots and stems. Toxic properties are a possible threat to humans through food chain contaminants.

Safe removal includes wearing gloves, bagging up the whole plant and tossing it in the bin.

DOG SAFETY GUIDELINES

Dog safety has been a recurring topic at the Board Meetings & Town Halls. Dog safety is paramount for all islanders – human and canine alike. Please read on for clarification.

Pierce County Leash Laws* do apply to the Riviera Community Club.

The RCC will follow those guidelines: Custodians must keep pets leashed and under control, collect any feces in a paper or plastic sack, and are liable for damage or injury inflicted

There are now six dog-friendly spaces in the Riviera. Leashed dogs ARE permitted in these areas:

Interlachen South (Tennis court side) & Ray Park (Volleyball side) South.

The two trails intersecting Lake Florence Drive & THE RCC Campground & Marina.

Dogs are **NOT** permitted at Interlachen (Boat launch) & Ray Park (Waterside) North, Pine Lake, and finger docks due to size or conflicting use (15 total sites.)

We appreciate your attention to these guidelines and wish you and your pups happy exploring!

FYI: Anderson Island Parks & Recreation: Dogs on a leash are allowed in 5 of the 10 island parks,
per <https://andersonislandparks.org/dogs-in-our-parks-1>

*Unincorporated Pierce County is officially a “Dog Control Zone”, and PCC code <https://pierce.county.codes/PCC/6.10.020> states: “Within a Dog Control Zone, any person owning or having charge, care, custody, or control of any dog shall keep such dog exclusively upon his own premises, except that the dog may be off the premises if it is under control of its owner or a competent person by a leash.
